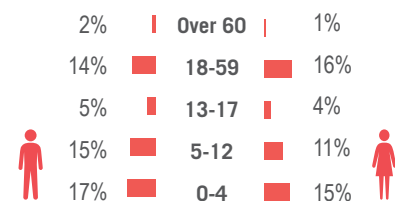
## Summary

This factsheet is designed to provide a brief overview of conditions and access to services in Tawakal 1. Tawakal 1 IDP settlement was established in August, 2013 as an informal site for internally displaced persons (IDPs).

Findings are based on primary data collected through household surveys conducted on 13/12/2015. Data is statically representative of the site population with a confidence of 90% and a margin of error of +/- 5%. Additional information was provided by community leaders on 13/12/2015, marked \*.

## Location Map



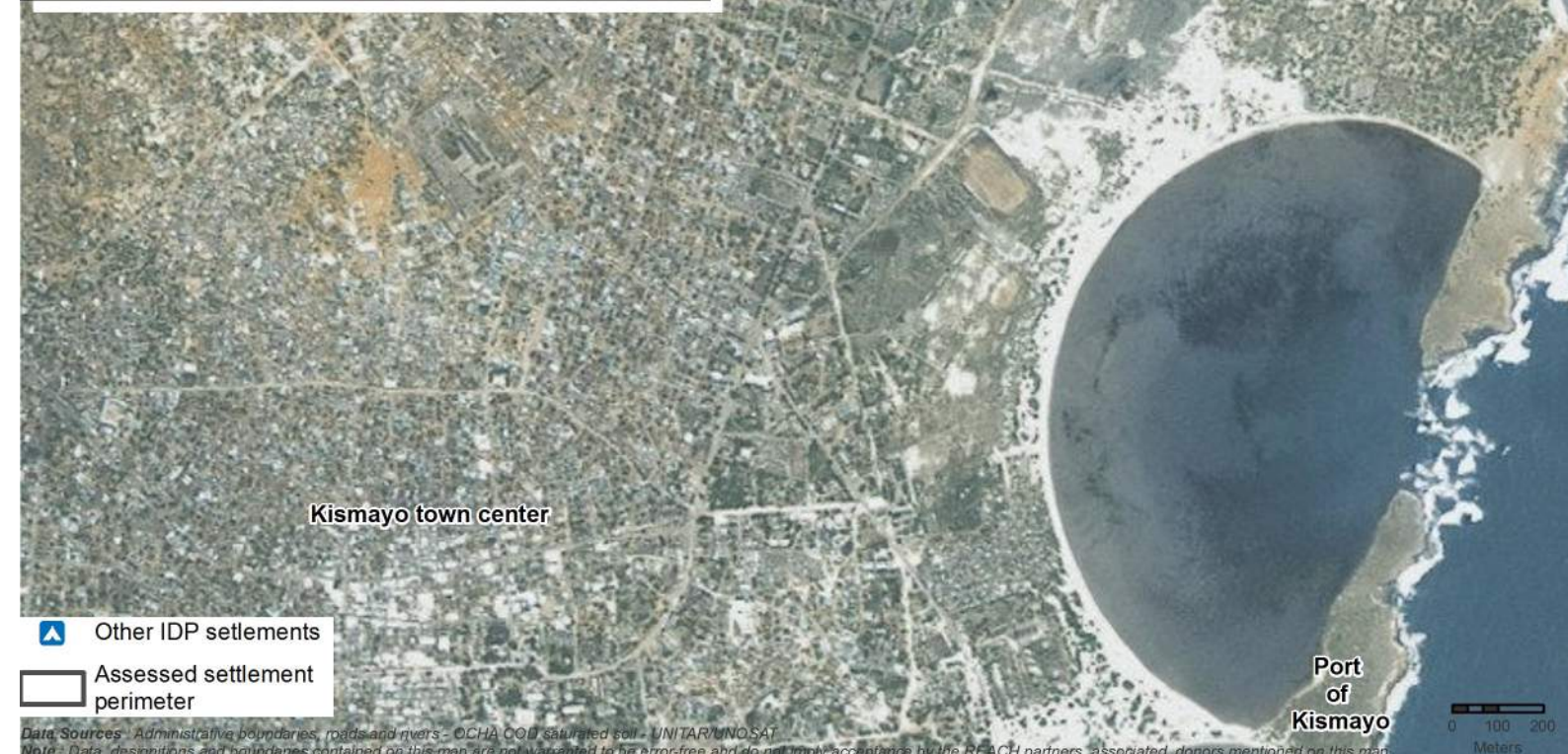

## Key Developments

Most IDPs in Tawakal 1 were forcibly moved from other settlements closer to the centre of Kismayo town in late 2014. Registration has been conducted only for 10% residents, by the local government. 94% of residents were dissatisfied with the shelter quality, reflecting the fact only emergency shelter items have been received, in around February 2015. Dry food distributions are made to the camp by SADO on a quarterly basis up until early 2015, since then SIF have conducted a dry food distribution during Ramadan. A cash for work programme run by SADO ended in late 2015.

A primary concern is the WASH services available in the settlement: there is only one water point for all 125 households. The dependence on groundwater sources means the water available to residents is salinated, although is still being used for drinking water. There are no showers available to settlement residents.
