

Key Developments

Tents in the camp have winterisation characteristics. All tents were raised on a concrete plinth and 99% had a secondary cover.

All households had received NFI assistance since the onset of the crisis. 34% had received hygiene kits, clothing was received by 29% and footware by 16%.

One challenge faced in the camp is access to water. 26% said they had not had enough drinking water in the past two weeks to meet household needs. 32% said they did not have enough clean water for purposes other than drinking.

63% had received food assistance in the past month. 1% had received a food package composed of less than a Family Food Parcel (staple carbohydrates, dry pulses, oil, sugar and iodized salt).


