

Mingkaman Snapshot

Awerial County, Lakes State, South Sudan

Summary

Following the outbreak of violence in December 2013, internally displaced persons (IDPs) started arriving in Mingkaman Site.

During the past months only sporadic new arrivals were recorded and a general decline in the population of the site was observed by camp management. It was noted also that people are coming back from Bor South County to attend the general food distribution.

Data was provided by IOM DTM and camp manager (as of 01/10/2015), spatial data was provided by REACH (as of 28/04/2015).

Location Map




