

# Yemen WASH Needs Tracking System (WANTS)

Salah District, Ta'iz Governorate

July 2022

The Yemen WASH Cluster launched the WASH Needs Tracking System (WANTS) with the support of REACH to provide high quality WASH needs data and inform more effective WASH programming and planning. The WANTS comprises a set of harmonized monitoring tools which, through partner data collection, provide updated information and analysis on WASH access and needs throughout Yemen.

The common household interview tool are household-level WANTS tool used in common priority districts. The findings below are based on nineteen (n=19) household interviews conducted across 2 communities in Salah district, Ta'iz governorate. Data was collected in July 2022 by Solidarités International (SI). The type of assessed localities were urban sites. These findings should be interpreted as indicative of the WASH needs in Salah district.

## Water

### Proportion of households reported using each type of main drinking water source in the 30 days prior to data collection:

6/19 of households were found to rely on unimproved water sources<sup>2</sup> in the 30 days prior to data collection.

4/19 of households reported having issues related to the smell, taste and/or appearance of their water in the 30 days prior to data collection. The following issue was reported:<sup>3</sup>

## Hygiene

15/19 of the households reported having soap available at place for handwashing
