SCOPE & COVERAGE

- Data collected between June and August 2022:
- Districts with at least 200 IDP or returnee households according to IOM-DTM Master List (March 2022)

64 districts in 18 governorates

26 IDP camps in 5 governorates

103 strata (pop. group per district/camp)

- **12,839 household surveys:**

2,342 In-camp IDP households

5,894 Out-of-camp IDP households

3,687 Returnee households


916 Host community households

- **Gender** in the MCNA X:

34% surveys answered by female respondents

28% of surveys conducted by female enumerators

14% of households reported to be female-headed



*Most districts with IDP camps hosted multiple camps. All 26 IDP camps in Iraq were surveyed.

DATA COLLECTION METHODOLOGY



Survey

- **In-person surveys with randomly selected households** about their (cross-) sectoral needs, vulnerabilities and intentions.
- Circa 150 questions: some at individual-level (e.g., schooling, disabilities); most at household-level

Sampling

- MCNA X data is **statistically representative at district level and by population group**
- Two-staged stratified cluster sampling approach
 - 90% level of confidence (10% margin of error) for IDP out-of-camp and returnee households
 - 95% level of confidence (5% margin of error) for IDP in camp households





Host Community Coverage

Rationale: to cover areas with data-proven needs of particular interest to DS actors, in order to align with and inform future objectives in programming.

Evidence-based suggested criteria from 2022 HNO:

- **District has more than 15,000 People in Need (PiN) of at least one pop. group in that district**
- **District has an average HNO Severity level 4 and 5 (out of 5)**

Limitations

- The absence of an Intersectoral PIN and Severity analysis limits quick bird's-eye analysis
- **Actors are encouraged to view the MCNA X (2022) Preliminary Analysis & Summary Tables to zoom in on areas/populations of interest, coupled with the MCNA IX (2021) Preliminary Analysis or Dashboard to compare cross-year**
- **Host communities were only surveyed in 10 high-vulnerability districts. Host community figures are representative for their district, but should not be considered to represent host communities throughout Iraq**
- **Almost all data is self-reported by households; REACH cannot guarantee veracity of self-reported data**



Top-5 most commonly reported household priorities nationwide (top-3 asked to HHs), by year*



- In 2022, Livelihoods, Shelter/Housing and Healthcare were reportedly top-3 priority needs for all pop. groups nationwide. Shelter/housing supplanted food since MCNA in 2021.
- In 2022, Shelter/Housing was reported as top priority among **61%** among out-of-camp IDPs, compared to **30%** and **31%** for Host communities and Returnees nationwide respectively











% of households with access to a safe and healthy housing enclosure unit (protection from elements)




- Critical shelter has slightly decreased cross-year due to sharp drops in **Al-Hatra, Al-Baaj, Sinjar, Al-Khalis, Tooz Khurmato, Daquq, Al-Rutba, Al-Hawiga, Al-Muqdadiya, Al-Falluja**
- Access to safe and healthy enclosure unit improved alongside critical shelter since 2021
- Majority of households in critical shelter live in informal sites*

*Critical shelter and informal sites were observed and recorded by enumerators. Critical shelter: damaged, makeshift, or non-residential shelters (tens, Refugee Housing Units, and religious or public buildings). Informal sites: more than 5 IDP families settled collectively; site not built to accommodate people; shared basic services; critical shelter; no formal management from authorities.





PROTECTION – MISSING DOCUMENTATION

- In 2021, 46 out-of-camp strata had 10%+ HHs missing at least one doc. In 2022, this decreased to 24 out-of-camp strata
- Highest proportions of HHs with at least one person reportedly missing a document: **IDPs out-of-camp in Duhok & Zakho** (50% and 46%% resp.), ALL pop. groups in **Al-Baaj** (48% district-level), and Hasansham U2 and U3 (49% and 47% resp.), and Khazer M1 (42%)
- **More female-headed HHs in 2022 reported lacking HLP docs than 2021:** in-camp (58% comp. to 42%); returnees (51% comp. to 37%)



















Bought food on credit or through borrowed money from relatives and friends - Stress strategy (30-day recall period)




Reduced expenditure on non-food expenses (e.g., health, education) - Crisis strategy (30-day recall)














Durable Solutions

CONCLUSIONS



CONCLUSIONS

- In many respects, MCNA 2022 data is consistent with MCNA 2021
- Smaller proportions of IDP households reported intending to return than in 2021
- WASH / SHELTER saw no substantial improvement
- Fewer households reported missing documents
- Reported irregular employment increased from 2021
- Female-headed HHs consistently reported earning less from employment/pension than HHs overall
- Reliance on non-employment sources (charity, assistance, loans) reportedly increased
- Reported application of coping strategies increased. Compared to MCNA 2021, households more frequently reported:
 - 1) borrowing money for food
 - 2) reducing non-food expenses
- Districts with the consistently highest degrees of cross-population vulnerability according to key indicators are in Ninewa, Al-Anbar
