

Al Yawa New Informal Camp Profile

Diyala Governorate, Iraq

Summary

Al Yawa New IDP camp was established in July 2014, and since November 2014 has been a formal site for internally displaced persons (IDPs) who had settled in the area. The main area of origin of the resident IDPs is Muqdadiya district, Diyala Governorate.

Primary data was collected through household surveys from the 19 - 25/11/2014. Additional information from camp managers, marked (*) is correct as of 01/12/2014.



Key Developments

In the last month 8% of households had received a food pack consisting of less than a standard Family Food Parcel (staple carbohydrates, dry pulses, oil, sugar and iodized salt).

98% of houeholds had received NFI assistance since the onset of the crisis. This included clothing, received by 27%, hygeine kits by 20% and footware by 9%. The most commonly reported needed items were gas fuel (reported by 67%), gas cookers (47%) and carpers (44%).

43% said they had not had enough drinking water in the last week to meet the household needs. 49% said not enough water was available for needs other than drinking. 6% said they did not have access to showers, 16% that they did not have access to latrines.
